I understand that the district may request residency verification documentation throughout the school year and I agree to supply requested documentation in the timeline requested in order for my child(ren) to remain enrolled in school. I understand that my landlord may be contacted to supply residency information. By signing this affidavit, I am affirming that the address given on all school forms is my legal residence. Further, I understand that giving false or inaccurate information on school forms, for the purpose of enrolling my child(ren) without paying tuition, is a criminal offense and my child(ren) may be withdrawn/excluded from school until the issue is resolved. If a determination is made that there was an attempt to defraud the district, Maumee City Schools will seek restitution and may file charges with local authorities to prosecute and recover reimbursement for tuition and legal fees from the party or parties responsible. I understand that those responsible will be held liable for all cost incurred while the student was enrolled in the Maumee City School District. New tuition rates are disbursed from the State of Ohio annually and will be charged accordingly. I declare under penalty of perjury that the information provided here is true and correct.
